#### 1. Certifying of Quorum-Call to Order

### 3. Agenda Items

**Landscaping:** Terrence indicated: new sod being installed, met with chemical treatment provider to review treatments and needs, vendor to email report and recommendations on regular basis, Golden Sun now working with Tru Green, trees are trimmed, working on other items around amenity center.

**Social Committee:** Patty indicated that the committee has planned the Annual Summer BBQ for August 11, 2012. The free tickets are available now and will be used for headcount purposes only. Signs have been ordered and will be placed around community. There are 16 youth from the community that have signed up to volunteer at the BBQ.

The 1<sup>st</sup> water aerobics class was held last Tuesday at 9:00am, there were 6 residents in attendance. There are other residents who have expressed interest. Depending on level of interest, they may schedule a 2<sup>nd</sup> class during the week.

**Open Board Position:** Tom opened the discussion regarding the Class III board position previously vacated by Elizabeth Hinkle. Tom recommended Richard Vogt as the candidate to fill the open position. The Board members asked questions of Richard Vogt.

Board asked manager to follow up with Fence Outlet regarding their offer to swap fence panels at pool area to improve ingress/egress of LSV from storage area at no charge. Manager will forward request to vendor.

Manager suggested that the Board consider granting settlement authority to any board member who may be called upon from time to time to appear in court on behalf of the Association.

On Motion: Duly made by Adam Bilbao, seconded by Richard Vogt and carried unanimously.

Resolve: To grant settlement authority to any board member or members who may be called upon from time to time to appear at a mediation or court function on behalf of the Association.

Broken Window - 536 Beth Ann: Manager indicated that the neighbors of 536 Beth Ann have expressed concern regarding appearance of broken window at this address.

On Motion: Duly made by Adam Bilbao, seconded by Chaplain Celerin and carried unanimously. **Resolve:** To approve the forced repair of the broken window at 536 Beth Ann at a cost not to exceed \$600.
