You may have noticed a few months ago that we had "radar signs" posted on Mt Carmel and Brentwood Hills Blvds. Due to a misunderstanding with the county as to required permitting, we were required to take those signs down.

The purpose of putting up those signs was to, hopefully, get the speeders to slow down in our community to provide for a safer environment for our children and our walkers. We have been

trying to get the county to tell us exactly what is needed for permits so we can reinstall our signs. To date, and its now been over six months, they have basically refused to deal with us. When the signs were

up, there was a marked decrease in the overall speeds going through our neighborhood. We fail to understand why the county is more interested in their bureaucratic red tape than the safety of our

children and residents. To that end, we are asking all of the residents to contact your local county commissioner and plead for him to intervene on our behalf. We would hate that the call to

action only comes after a speeding vehicle has struck someone, especially a child! We had three accidents in December, two on Mt Carmel and one of Lumsden, directly related to excessive speed.

The Pool is Almost Ready—Check Your Cards

We are still in the process of updating the information on each homeowner/

resident's pool access card. Each address is allowed one pool access card. Due to a high turnover of residents, particularly with our renters, we have found a multitude of addresses with

as many as four access cards registered. Our pool attendant has gone

through all of our records, and tried to determine which access card is most cur-

rent. She then has deactivated all other cards for that address. The process is not perfect, so if you find your card deactivated, please go to the pool office to have your records updated. The attendant is

on duty from 1:00 pm till 6:00 pm every day.



The architectural standards for our community are detailed within the governing documents. ANY and ALL changes you intend to make that affect the outside appearance of your home or yard are governed by the ACC rules. That means you MUST submit a written request and get approval in writing before attempting to make any changes, repaint, reroof, put in a fence, etc. You

can download the form from our website: www.mybhhoa.com; or pick one up from the pool office. There are color books in the office, as well, if you are thinking of repainting the exterior of your house. Once the ACC request form is filled out, it can be turned in to the office or submitted to McNeil Management.
