# **COMMUNITY PROJECT UPDATES**

### **FOREST AREA**

Many may have noted the recent activity in what is to be the forest area. The area, at the moment, looks dead and generally unpleasant due to the many dead weeds and grass caused by the herbicide. Herbicide is a chemical that kills off any weeds and grass that could compete for nutrients with the soon-to-be planted saplings. In the next few weeks, a process called "disking" will be used on the forest area. Disking is a process that consists of a large tiller churning the top layer of soil, allowing for another round of herbicide to be applied to the area. This second round of herbicide ensures the weeds are dead. The trees to be planted after the second herbicide application are seedlings, but will be the same size in 5-10 years, if not bigger than, the previous trees that were in the full forest. The trees will continue to grow and adapt to the area better due to the lack of competition for nutrients. These new baby trees should be planted by late February, early March, depending on the weather at the time.

#### **MONUMENTS**

The demolition the monuments has been waiting for TECO to remove the electric meters and electricity from the monuments, allowing demolition commence. The letter confirming power has been removed has just been received so we anticipate movement on the monuments very shortly--at least, that is our hope. We expect monument construction to be completed by March 2018.

## **CRIME**

Brentwood Hills has been experiencing a recent rash of petty and even serious crime. The board sees this as a primary factor to maintaining a healthy living environment and preserving our home values. During the annual BH HOA meeting, March, we will be hosting the Hillsborough County Sheriff's Office and discussing effective and lasting solutions regarding this matter. While we are looking at various solutions, we ask residents to keep a close eye throughout the neighborhood.

### **ANTI-CRIME MEASURES**

The board is exploring cost-effective measures for addressing the spate of criminal activity. This will be discussed in depth following the March presentation by HCSO.

#### **DOG PARK**

The board is addressing the potential for a cost-efficient Dog Park within the community. Such a feature is common among today's communities and is essential to maintaining Brentwood Hills' ability to compete for home buyers, thereby maintaining property values. This subject will be on the agenda for discussion during the February meeting.

#### **IRRIGATION SYSTEM REPAIRS**

The irrigation system has been experiencing more than usual challenges. We are bringing in a specialist to look at the very complex system that the original developers installed. We are seeking opportunities to avoid the regular and costly repairs.

#### **MARQUEE**

We are looking at erecting an "Activities" sign in front of the pool facility. We have historically used the "lawn signs" but the idea has been put forth to replace all of those with one main sign in front of our clubhouse. We spend a lot of your money on these "lawn signs" every year as they tend to disappear shortly after being put out. The one main sign should save us money in the long run and the message will be able to be changed as needed.
