**General Tree Work:** Board requested a quote from Panorama for trimming oak trees throughout community.

- 13 trees located along south side of Lowes retention area
- 9 located along north side of Dew Bloom
- All along Mt. Carmel and Brentwood Hills Blvd

**On Motion:** Duly made by Olin Barnett, second by Gerri Clifton and carried unanimously. **Resolve:** To allow up to \$2500 for general tree maintenance before next meeting if needed.

**Perimeter Fence:** Tom said he believes there are still some sections of fence that are faded and need to be replaced along Brentwood Hills Blvd. Tom will follow up with New Tampa Fence regarding problem areas.

**Monuments:** The Board discussed various items regarding the monuments. Tom will provide a list of all board concerns to Folsom for review/response.

#### **BOD Comments:**

Olin suggested the HOA have pavers or a concrete pad poured near the pump house, as a place to store fence supplies, etc.

Olin also suggested that the HOA install a paver walkway from the sidewalk areas in front of the amenity center into the parking area, to allow pedestrians to enter the amenity center without relying on the vehicle driveways.

Charlie suggested the HOA include a POW/MIA flag on the flag pole, along with the US flag.
